Preparation of MGNREGS Labour Budget and Integration with GPDP



Introduction

- Labour Budget (LB) under <u>Mahatma Gandhi National Rural</u> <u>Employment Guarantee Act (MGNREGA) 2005</u> refers to advanced labour estimate for execution of a shelf of works for the next financial year
- The advance assessment of labour demand in a district takes into account seasonality aspects along with the examination of employment and livelihood opportunities in the respective rural areas
- LB entails planning, approval, funding and project execution modalities under MGNREGA. Sub-section 6 of Section 14 of MGNREGA mandates the District Programme Coordinator (DPC) under MGNREGA to prepare in December every year a labour budget for the next financial year.

LBs are prepared in accordance with the provisions made in sections 13 to 16 of MGNREGA and processes defined in **Chapter 8**, **para 8.4** of <u>Operational Guidelines</u> of MGNREGA 2005

Gram Panchayat Development Plan (GPDP)

The **GP development plan (GPDP)** will have to have a clear component addressing vulnerabilities of **poor and marginalised people** and their livelihood opportunities through **an integrated** poverty reduction plan that **converges with the labour budgeting** and **projectisation exercises under MGNREGS as well**. (GOI Guidelines 8th Oct 2015)

in the formulation of priorities and projects and will also have to ensure the mandates of

- social justice and
- economic development

- Infrastructure Development


Social Audit

Social Audit is a tool for social accountability and transparency

"Audit of Schemes Rules 2011" under the sub-section (1) of section 24, of the MGNREGA 2005

Components of social accountability includes

- * Collection
- * Analysis
- * Dissemination of information
- * Mobilization of Public support
- Advocacy and negotiation for change



COMMUNITY MOBILIZATION

Community mobilization is a process of involving and motivating people, health workers and policy makers to organize and take action for a common purpose in order to achieve sustainable development to come forward to demand and use certain services.

It stimulates families to make intelligent, informed and free choices of demanding and using services

Eg. raising immunization coverage for the target groups, reduce vaccine preventable diseases of childhood, reduce drop-out rates,
